*Candidates who will complete all requirements for the degree by June 2024 may also apply. Candidates in the last year of degree should have obtained minimum 50% aggregate (45% for SC/ST category) in the latest examination.


XAT 2024 (Applicants under Achievers/ELITE round may also apply using XAT 2023)

What is Achiever's Round?

The candidates for Achievers Round shall be shortlisted without CAT/ XAT or GMAT to facilitate interview process in selected cities.

Academic toppers from a selected set of institutes are invited to Achievers round as ELITE applications. All ELITE applications will be given opportunity to appear in the Interview process, after verifying the eligibility (alma mater and status as topper).

Competitive exams scores will be incorporated later. An offer for spot Admission shall be given to select set of candidates others will be considered for admission in April.
