The two-year full-time Post Graduate Diploma in Management (PGDM), approved by the All India Council for Technical Education, Government of India and recognized by the Association of Indian Universities (AIU) as equivalent to an MBA degree of an Indian University, is consistently rated among India's top 10 programmes.

Eligibility Conditions:

PGDM, PGDM-HRM and PGDM-Business Analytics

- The candidates must have 50% marks or equivalent CGPA in both class X and XII.
- The candidate must have minimum 3-year Bachelor's Degree, with at least 50% marks or equivalent CGPA in any discipline from any University incorporated by an Act of the Central or State legislature in India or other educational institutions established by an Act of Parliament or declared as deemed to be University under Section 3 of UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India.
- A Bachelor's Degree or equivalent qualification obtained by the candidate must entail a minimum of three years of education after completing higher secondary schooling (10+2) or equivalent. Candidates appearing for the final examination for the Bachelor's degree (or equivalent examination) and completing all requirements for obtaining the Bachelor's degree by 30th June, 2024 can also apply, subject to furnishing evidence to that effect latest by 31st October, 2024; otherwise, they may be asked to withdraw from the programme.
- In addition to the above requirements candidates applying to PGDM-IB must have a minimum of 1 year (one year) post-qualification work experience as on 31st January 2024 after completing 4-year's Bachelor's degree.

Indicate only paid and full-time work experience, acquired after completing the Bachelor's Degree. Apprenticeship, Articleship, Internship etc. which form an integral plan of a course of study should not be treated as work experience.

PGDM – IB is a twining programme in collaboration with ESCP Europe. On successful completion of PGDM – IB, student will be awarded a Post Graduate Diploma in Management-International Business (PGDM-IB) from MDI Gurgaon and MiM (Masters in Management) from ESCP Europe.

CAT 2023	Applicants must have a COMMON ADMISSION TEST (CAT)2023 to be eligible for admission to the PGDM, PGDM-HRM, PGPM-IB & PGDM-Business Analytics programs of MDI Gurgaon. Applicants can apply only on the basis of valid CAT-2023 score. However, only the NRI candidates may apply through valid GMAT score. GMAT Score for Indian candidates is NOT APPLICABLE .
